Madrid, July 14 2022 - Applus+, a global testing, inspection and certification company, is pleased to announce the agreement to acquire the entire share capital of K2 Ingeniería S.A.S (K2), a provider of environmental consulting and monitoring services based in Bucaramanga in Colombia. Closing of the transaction is expected within the next few weeks. The experienced senior management team will continue ensuring a smooth integration with Applus+.

K2 was established in 1999 and currently employs 257 professionals serving five key service lines: Environmental Consulting, Environmental Monitoring, Technology, Water Engineering, and Power Engineering. Its revenue in 2021 was €13 million.

Within the framework of sustainable development, K2 advises clients on diagnosis and problem solving with regard to environmental and social matters, developing projects focused on air and water quality, waste, noise, meteorology, and flora and fauna management.
